CONDITIONS FOR LEASING

 - a. Individuals are required to provide the following:
 - (i) Copies of their Identity documents (Omang /Passport) and Certificate of Naturalization in case of those born outside Botswana.
 - (ii) Latest pay slip and 6 months' recent bank statements
 - (iii) ITC clearance certificate for the applicant (should not be more than 3 months old)
 - (iv) Married applicants must provide certified copies of their marriage certificates, Identity Documents of spouse and consent from spouse to apply for accommodation.
 - (v) Affidavit stating that neither them nor their spouse rent or own a property obtained directly from BHC in Gaborone or surrounding area.
 - b.Citizen owned or controlled companies are required to provide the following:
 - (i) Copy of company registration certificate certified by the Registrar of Companies.
 - (ii) Copies of share certificates and Identity Cards of shareholders certified by Registrar of Companies.
 - (iii)Certified copies of Certificates of Naturalization, if shareholders were born outside Botswana.
